

# 2010 – INDIANA MIDDLE SCHOOL TEAM STATE CHAMPIONSHIPS

- Date: Sunday, January 10, 2010
- Location: Yorktown, Indiana (Yorktown High School/Yorktown Middle School)
- Sponsor: Yorktown Wrestling Club (Tournament Director: Trent McCormick)
- Event will be sanctioned through USA Wrestling
  - Competitors shall have their USA card to be covered by insurance
- Weight Classes: 70, 75, 80, 85, 90, 95, 100, 105, 110, 115, 125, 135, 145, 155, 165 & HWT (max 225)
- Age Requirement: Wrestlers must be currently enrolled in the 6<sup>th</sup>, 7<sup>th</sup> or 8<sup>th</sup> grade at the school they are competing for at this event. In addition wrestlers cannot turn 15 years of age before July 1, 2010. Coaches will be required to bring a copy of each wrestler's birth certificate to the event.
- Team Requirements: Each team may have up to 25 participants. All wrestlers on a team must attend school at the same place/school. This is not an all-star event. Coaches will be required to provide copies of their wrestlers' quarter 1 or quarter 2 report cards for school verification. (ex. – 2 middle schools in same district may NOT combine to make one team)
- Event Format: 4 pools to begin event – Top 2 teams from each pool then entered into a bracketed 8 team championship mini-tournament. (9 – 12 full size mats will be used)
- Number of Matches: This will depend on the # of teams entered in the event. We will attempt to get every team a minimum of 5 dual meets on the day.
- Team Awards: Top 4 teams will receive custom awards and each wrestler on the top 2 teams will receive a custom award.
- Individual Awards: All wrestlers who go undefeated for the day with a minimum # of matches (dependent on number of teams entered) will receive a first team All-State certificate.
- Special Awards: One Outstanding Wrestler award will be given for the event (voted by coaches). One Technical Superiority award will be given for the event (voted by coaches).
- Cost: \$250/team (this equates to \$10/wrestler for a team of 25 kids)
- # Teams: Tournament will be capped at first 24 teams to sign up and send entry fee.

Exhibition

Matches: Teams will be permitted to wrestle 2 exhibition matches at the end of each round.

Weigh-in: On site weigh-ins Saturday evening and Sunday morning.

Procedures: Scratch weight – no allowances. Wrestlers will weigh-in wearing their competition singlet.

Mat

Officials: Licensed mat officials will be used for this event.

Table Help: Each team entered in the event will be required to provide one score table worker each round for timing and scoring responsibilities. This person will be admitted into the event free of charge.

Team Entry: Those interested in entering a team into this championship event should contact Coach McCormick for a team entry form or fill out the application below. Weigh-in forms will be distributed during the week prior to the event. Entry into this event will be based on a first come-first serve basis.
